DIRECTOR'S REPORT

Scribner presented the directors report. The new 6311 Ambulance is in service as a front line ambulance. Josh has secured a second vehicle for purchase.

The new SMCAS Website is nearly complete. We are putting the finishing touches on it and should be online in the near future.

We have completed our medical coverage for the MxON international motocross races, September 23-25. The event saw over 80,000 spectators and participants from 56 countries. Our crews did a phenomenal job of simultaneously caring for our community and the event.

Scribner met with Dr. Beyer regarding concerns over the amount of mutual aid we are providing for Pride Care Ambulance. Scribner will present a draft memo to the board describing control over Mutual Aid Abuse from neighboring agency(s)

In September, SMCAS received 154 Priority 1 requests for service. We achieved better than 90% on-time performance for calls within our coverage area.
